## Payment Agreement

### KNOW ALL MEN BY THESE PRESENTS:

This Contract is entered by and between:

Janet Weldon, of legal age, Married, U.S., whose principal place of address is at 3060 Vesta Drive, Lynn Street, Oakland, California, 94622, (hereinafter referred to as "DEBTOR");

- and -

David Lyke, of legal age, Single, U.S., whose principal place of address is at 731 Simpson Avenue, Clay Lick Road, San Jose, California, 95128, (hereinafter referred to as "CREDITOR");

### WITNESSETH: That -

WHEREAS, the DEBTOR has an existing obligation to the creditor for an amount of \$ 3,000.00;

WHEREAS, the DEBTOR and the CREDITOR, by the goodwill of both parties, desire to secure the amount of debt by entering into a new agreement whereby the sum of \$ 3,000.00 shall be set into structured payment agreement to the terms and conditions herein provided;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereto agree as follows:

#### 1. Debtor Representation

The DEBTOR hereby represents and warrants that both parties in this agreement have set a payment plan to secure the deficiency in a scheduled manner set herein without further interruption, notwithstanding an additional fee for processing of such scheduling.

#### 2. Payment Plan

The Parties hereby agree to the scheduled payment plan, as to the declaration of its contents found on Exhibit A attached hereto (the "Payment Plan"). The DEBTOR shall conform to the schedule set and shall pay to the CREDITOR before or upon due the amount as indicated on the Payments Schedule table.

#### 3. Payment Method

Payment shall preferably be made to the CREDITOR in accordance to the mode as indicated in the Payment Plan, but in any case, the DEBTOR may choose his method of payment to his convenience.

This also serve the purpose of renewing our passport using married name and if we plan to become a dual citizen. If Filipino applicant is divorced and divorce was initiated by foreign spouse, one (1) original or certified true copy and four (4) photocopies of DFA-authenticated Judicial Recognition of Foreign Divorce issued by a competent Philippine Court with Certificate of Finality. If either groom or bride is widowed, one (1) original or certified true copy and four (4) photocopies of the Death Certificate of deceased spouse (Original supporting documents will be returned). The Philippine Consulate General will convey the Report of Marriage and annexed documents to the Philippine Statistics Authority (PSA) of the Philippines. Ok now after 2 weeks of waiting, the verdict is in! They returned all my papers together with a note. Please leave your contact details so that the consular officer or consular assistant can reach you immediately. Wives should indicate their maiden name as the last name. 2. I heard some ROM filers who filed their ROM right after the wedding didn't require notarization through mail. If the Report of Marriage is filed after 12 months of the date of marriage, a Notarized Affidavit of Delayed Registration of Marriage must be accomplished. Address the mail to: Civil Registry Unit (Report of Marriage) Philippine Consulate General 556 Fifth Avenue, New York, NY 10036 To be honest I'm lazy doing this. ONLY marriages contracted in the following places can be registered or reported at the Philippine Consulate General, Los Angeles, CA: (1) Southern California; (2) Southern Nevada (Clark, Lincoln and Nye Counties); and (3) Arizona. See on - Phil. Factors such as citizenship, previous civil status and others may affect the status of your application. If Filipino, it must be the birth certificate issued by the Philippine Statistics Authority (PSA) (formerly National Statistics Office or NSO). Please take note of the mailing or courier tracking number since the Philippine Consulate General cannot assume responsibility for documents which have been mailed through the U.S. Postal Service or courier service. Although we already past one year - it's still cheaper to have the Notary for Late Registration Explanation Letter (2 copies = \$40) than having to notarized those 4 ROM forms for \$80. Divorce, however, must be recognized in the Philippines courts. Once emailed documents have been determined to be complete and in order by the Consular Officer, the informant mails to the Consulate the ROM Application packet (please see below the contents of the packet), taking note of the envelope's tracking number. If it didn't succeed you still have a lot of time to have the ROM forms notarized or wait for Outreach program near your area to file the ROM without cost. Important Note: Marriage must be reported within one year upon the solemnization of marriage to the consulate otherwise need to accomplish a Notarized Affidavit For Delayed Registration or Marriage. If Filipino applicant had a previous Philippine marriage annulled, an original and four (4) photocopies of the Philippine Statistics Authority (formerly National Statistics Office/NSO) (PSA) issued Annotated Marriage Certificate (which indicates the details of the annulment) and/or DFA-authenticated Judicial Decree of Annulment with Certificate of Finality. Four (4) photocopies of a government-issued identification card or passport of both husband and wife. Additional Requirements: 1. The Report of Marriage must be filed with the Philippine Embassy or Consulate which exercises jurisdiction over the place of marriage. Provide a self addressed stamped envelope or pre-paid courier envelope or Pay an additional \$6 as mailing fee for their feedback mail. If submitting by mail, the complete forms must be notarized. (click here for the fillable form) Click here for sample of Filled up Form One (1) original and four (4) photocopies of the Marriage Certificate or Contract (original will be returned). There's no harm in trying. In my case is the Philippine Consulate in LA. The foreign divorce decree must be judicially enforced or confirmed in the Philippines by filing the proper civil action at the Regional Trial Court in the Philippines (RTC-Phil). Disclaimer: I am no expert and wrote this only base from my experience, requirements may vary depend on your jurisdiction. Always check the latest requirements on this site - Report of Marriage of Filipino Abroad and check which consulate jurisdiction you belong at - Phil Consulate Jurisdiction Finder. LA Consulate Note: All Duty Accomplished ROM Form should be notarized. Take note that filing a ROM by mail, accomplished ROM form should be notarized - However even though I am filing it through mail - I took the risk of submitting my accomplished ROM without notary since the original marriage certificate itself is already notarized. Might as well just give it a try. c. One (1) original and four (4) photocopies of the Birth Certificate of the husband. ROM (Report of Marriage) without Notary was REJECTED!!! Ok Phil. It takes at least six (6) months to about one (1) year for the ensuing Philippine Certificate of Marriage to be available for ordering from the PSA in the Philippines. I filed my ROM after I received my green card before our 1st year anniversary of marriage. To know the location and contact details of Philippine Embassies or Consulates, please check here. Personal check and credit cards are not accepted. Embassy having jurisdiction over the locality where the wedding took place. And then from here, I created my own checklist applicable to my case and have it mail to the Phil Embassy. 4 original filled-up ROM Form (without notary!) Note again that it should be submitted: a. Update 09/04/15: Notarization of 4 ROM forms cost \$80 (\$20 each) in our area in San Diego Ca. It's kind of a pain so I will just wait for the LA Consulate Outreach Program in our area this coming November 2015. It seems like an extra task however this is important in order for our marriage here in the US be reported to the Civil Registrar of the Philippines through Phil. Divorce is not recognized in the Philippines but when a divorce is validly obtained abroad by an alien spouse from his or her Filipino spouse, the Filipino spouse shall have the capacity to remarry under Philippine law.
