Original signatures are then affixed to both to create a valid contract and can be used to verify the transfer of ownership. If there is no place to include the actual odometer reading, you will need to submit an Odometer Disclosure Statement. If the vehicle was built before the year 2000, it will not require a title, but you will need to furnish the previous owner's registration. An accepted method of payment for all state taxes and fees Massachusetts requires the formal course of registration solely for guns purchased in another state, guns inherited, or for guns belonging to residents relocating from outside the state. To begin the process, you can visit The Massachusetts Gun Transaction Portal. When procuring a firearm from within the state, it will require an individual to first apply for a License to Carry or a Firearm Identification License, essentially registering the weapon. To legally carry a gun in a concealed or open manner will obligate a resident to apply and gain access to a License to carry. You can do so by visiting the local authorities with the below-listed paperwork: The Massachusetts Registry of Motor Vehicles does not offer a standard bill of sale form that you can fill out. If you decide to write your own bill of sale, make sure to include the following information: Date of sale Cost of vehicle purchase Your full name and address Buyer's full name and address Vehicle's year, make, model, identification number and mileage Acknowledgement of any liens held on the vehicle After you and the buyer sign the bill of sale, you should make a copy for yourself and hand the buyer the original. You can also download a generic bill of sale from Digital Federal Credit Union. If you need to sell a vehicle and you are out of state, you may give someone a limited power of attorney just for the purpose of the vehicle sale. When you've purchased a vehicle, make sure you have all the information needed to get your car registration and title. The Massachusetts RMV provides this checklist. Does a bill of sale need to be notarized in Massachusetts? There is no legal requirement to notarize a bill of sale in Massachusetts. What paperwork do I need to sell my car in Massachusetts? To sell your car in Massachusetts, you will need a vehicle certificate of title. The new owner will need the title to register the car. If you do not have your car's certificate of title, you can order a replacement certificate of title through the Massachusetts registry of motor vehicles. You are not required to have a bill of sale in Massachusetts, but it's a good idea to get one for your records. Updated Oct. 16, 2019 A Massachusetts bill of sale is used to document the private sale and transfer of personal property from a seller to a buyer. The completed form includes a description of the item being sold, the purchase price, the date of sale, and both parties' signatures. When selling a used motor vehicle or vessel, the seller should always provide a bill of sale for the buyer to use as proof of purchase and ownership. The new owner can then use the bill of sale to register the newly acquired vessel or vehicle with the appropriate state authority. Download: PDF, Word (.docx), OpenDocument Motor Vehicle Firearm Boat The Commonwealth of Massachusetts does not require a Bill of sale form for vehicle transactions if a title is available. But if the vehicle transaction involves a car that is exempt from titling, a Bill of Sale (along with the previous registration) must be presented in order for the new owner to register the vehicle. A Bill of Sale is a document created by a buyer and a seller as a means of documenting the sale of a motor vehicle. To be a legal document, the Bill of Sale must contain the following information:- The buyer's name, address, and signature. - The seller's name, address, and signature. - Model, make, model year, and Vehicle Identification Number of the vehicle. - Date of purchase. - Purchase price. - Odometer reading. In the Commonwealth of Massachusetts, a Bill of Sale does not need to be notarized. Private Sale To obtain a Title for a used vehicle purchased from a non-dealer, the following are required: 1. A completed and signed Registration and Title Application - the old RMV-1 Form. If the vehicle is going to be registered, the Registration and Title Application Form must be stamped by the insurance company. Checklist for a vehicle purchased from an individual. 2. One of the following documents must be submitted along with the completed Registration and Title Application or the old RMV-1 Form. - The previous owner's Certificate of Title or - The previous registration and a Bill of Sale, if no Title is required for the vehicle because of its age. In Massachusetts, a 1980 model year or older passenger vehicle purchased by the current owner prior to November 26, 1990 would be exempt from titling. Other states may exempt vehicles from their titling requirements based on the model year of the vehicle. If a Bill of Sale is being submitted, the document must list all required information. Additional documentation is required for imported foreign/grey market vehicles and specialty vehicles. 3. Certificate of Title fee, due at time of submission of the Registration and Title Application. When a customer sells a motor vehicle in a private transaction, he/she must write the following on the Assignment of Title section provided on the back of the Certificate of Title:- Date of sale. - Purchase price. - Name, address, and signature of the buyer(s). - Name, address, and signature of the seller(s). - Odometer reading. Note: If the Title does not have a sales price section or if the vehicle was exempt from title, then the customer must complete a Bill of Sale. See the Title Fees section for the applicable fee - Revised January 2022. Transferring Salvage Vehicles for Individuals The owner of a Total Loss Salvage motor vehicle must disclose to the buyer or transferee that the vehicle has a Salvage Title. The owner of a Total Loss Salvage motor vehicle for which a Salvage Title has been issued must sign the Title over to the new owner on the space provided on the Title and deliver the Title to the new owner. The new owner must apply for a new Salvage Title within ten days of delivery. If an owner wishes to sell a salvaged vehicle that he/she has repaired, he/she must take it through the salvage inspection process and apply for a Reconstructed or a Recovered Theft Title, whichever applies. If the vehicle has not been repaired, the owner should advise the buyer that the inspection and Title process is required before the vehicle can be registered to drive. A Massachusetts bill of sale form is a legal document used to record the sale of personal items in the state of Massachusetts. Bills of sale are particularly useful (and sometimes required) when selling property such as vehicles, boats, and firearms, as they help legally protect both the buyer and seller in the event of a dispute. In Massachusetts, some bills of sale will need to be notarized before they can be signed by both parties and made official. In many states, a bill of sale is required to register a vehicle at the Department of Motor Vehicles (DMV). Check out Massachusetts Horse Bill of Sale Massachusetts Bill of Sale Requirements The Massachusetts Registry of Motor Vehicles (RMV) does not specifically require a bill of sale for vehicles, unless registering a vehicle that is exempt from titling. In that case, a bill of sale and a previous registration are required in order to register the vehicle. A bill of sale is, however, required in order to sell, purchase, or register a vessel. Language Requirements Massachusetts does not provide bills of sale or any other forms in other languages, but the RMV does provide interpreters to translate documents and the parties' answers to questions asked on forms. Any translation must be accompanied by a Translation Certification Form in order to be considered valid. Number of Copies Since a bill of sale is not always required in vehicle sales transactions, only two copies, one for the buyer, and one for the seller should do. However, in-vessel transactions and vehicle transactions where bills of sale are necessary, an extra copy will need to be filed with the Boat, ATV, and Snowmobile Registration Bureau or the RMV. Massachusetts Vehicle Bill of Sale Requirements Bills of sale in Massachusetts, while sometimes required, do not have to be notarized. While Massachusetts does provide a form, you can also hand-draft your own, or use a custom vehicle bill of sale template. All bills of sale, however, should contain the following criteria: The names, contact information, and signatures of the buyer and seller The sales price The purchase date The vehicle identification number (VIN) Identifying information regarding the vehicle The make, model, and year of the vehicle After Purchasing a Vehicle In addition to a proper bill of sale, there are many other items that you must complete and submit in order to register your vehicle in Massachusetts. Here is a brief list: Dealership Sales For buyers: In Massachusetts, the dealer will usually take care of all registration and titling paperwork for you. Private Sales For sellers: Fill out the seller-indicated area of the certificate of title, including the odometer reading, and sign and date it. Then pass it to the buyer. All vehicles built after the model year 1980 must have the original title in order to be sold and registered in the state. You may sell a vehicle that is older than the model year 1980 without a title, as long as it was purchased prior to November 26, 1990, and you have a bill of sale and the current registration. You must remove the plates from the vehicle immediately. You may attach those plates to a new vehicle, but you must do so within 7 days of selling the previous vehicle. For buyers: You must fill out the Application for Registration and Title, or RMV-1 Form. Once you insure your vehicle, your insurance company will have to sign and stamp the form to prove that the vehicle was insured prior to the registration process. You can title and register your vehicle simultaneously in Massachusetts. You will need to appear at your local RMV office in person with the certificate of title, signed by you and the seller, with the price indicated on it. If the price is not written on the title, or the car is too old to require a title, you will need a bill of sale, indicating the price, and the current registration. You must also bring the Application for Registration and Title, or Form RMV-1, already stamped by your insurer, and money to pay the registration and titling fees and sales tax. Sales tax, without a bill of sale or an indicator of the price on the title, is based upon the type of vehicle you are registering and its current market value. However, it is usually assessed at 6.25% of the purchase price. Additional fees include a title transfer fee of \$75, and either a registration fee of \$25 for transferred registrations, or a registration fee of \$60 for new registrations and plates. You will get your new title and plates immediately afterward at the RMV office. You have 10 days to title and register your vehicle unless you are transferring your registration from a prior vehicle. In that case, you will have 7 days from the day you disposed of the previous vehicle. Once your vehicle is registered, it must be inspected for safety and tested for emissions within 7 days, even if the last inspection is still considered valid. Inspection stations are found throughout the state. Inspections will need to be conducted annually once the vehicle is registered. Massachusetts Boat Bill of Sale Requirements A boat bill of sale is required in order to sell, purchase, or register a vessel, and an official form is provided on the state of Massachusetts website. Make sure your boat bill of sale includes the following information: The names, contact information, and signatures of the buyer and seller The make, model, and year the vessel was built The company letterhead, if the vessel was purchased from a business The hull identification number (HIN) The length of the vessel Whether or not the vessel includes a trailer or motor Some RMV forms in Massachusetts feature a penalty of perjury printed upon them, though the bill of sale does not. If you are hand drafting a bill of sale, you may choose whether or not you would like to include one. However, the state does consider any perjury to be a felony and allows it to be litigated in the District Court with potential punishments ranging from a \$1000 maximum fine and/or up to 2 and 1/2 years in jail. After Purchasing a Vessel Dealership sales: For buyers: You will need a bill of sale from the dealership, as well as a manufacturer's certificate of origin and the documents indicated below to register your vessel in Massachusetts. The dealer cannot register and title your vessel for you. Private sales: For sellers: If you are selling a vessel that originated from a non-title state, the current registration can be used in lieu of a title to prove ownership for selling purposes. However, if the vessel originates from Rhode Island, you must have your signature on the title notarized in order to transfer ownership. For buyers: You may pay your vessel sales tax online and print out a receipt. If your date of manufacture is prior to 1972, or your HIN does not have proper U.S. Coast Guard formatting, you may need an inspection prior to registration. You must visit one of the five Boat, ATV, and Snowmobile Registration Bureau offices in order to register your vessel. You must bring with you a bill of sale, a completed Registration and Titling Application, or Form ELE #1, the certificate of title signed over by the seller (for boats 14 feet long or over), a pencil tracing of your HIN, Massachusetts Department of Revenue (DOR) Form ST-6 or Form ST-6E, indicating that your sales tax was paid or you are exempt, and a check or money order for applicable fees. Sales tax in Massachusetts is set at 6.25% of the total purchase price of the vessel. It is due on the 20th day of the month following the purchase date. If payment is late, there will be penalties and interest. Registration is for 2 years and the fees are as follows: Boats under 16 feet \$44 Boat length 16 feet to less than 26 feet \$66 Boat length 26 feet to less than 40 feet \$88 Boat length 40 feet and greater than \$110 Boat Title \$27.50 Duplicate Title \$16.50 If your vessel requires a HIN, then HIN placement must be proven prior to the receipt of your new registration and decal. Massachusetts Gun Bill of Sale Requirements In Massachusetts, you must have a state permit to carry any firearm, but there is no official registration. Unofficially, firearms must be recorded with the Massachusetts Executive Office of Public Safety and Security (EOPSS), and firearm bill of sale information can be submitted electronically online.
